A non refundable deposit of \$300 is required for a male or female dog sold under this contract.

The dog is sold as a pet only and cannot be bred under this contract. All registration papers will be withheld until proof of spaying or neuter is received by the seller. Puppy is to be paid in full by 4 weeks of age unless other arrangements made.

**Seller's Responsibility:**

1. The Seller guarantees the puppy is in good health, is up-to-date on immunizations appropriate for the puppy's age and has had appropriate wormings at the time the Buyer takes possession.
2. The Buyer has three business days to take the puppy to a veterinarian for an examination. If the puppy is found to be in poor health the Buyer has the option of returning the puppy to the Seller, at Buyer's expense for a full refund, or keeping the puppy. The Seller will reimburse for all veterinary costs, up to the purchase price, related to treatment of said pre-existing condition. If the puppy is not taken to a licensed veterinarian within the three business days, the Healthy Warranty is void.
3. The Seller provides this warranty for two years after the date of sale against any debilitating congenital defects. In the event the puppy exhibits symptoms of a suspected debilitating congenital defect, the Buyer must supply any requested veterinary records to the Seller.
4. This warranty does not include viral illnesses, infections, improper bites, hernias, hypoglycemia, worms, Guardia or Coccidiosis. It also does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury.
5. If it is determined the puppy does have a genetic disorder that is identified within two years of purchase, we will either (at our discretion) refund up to the original purchase price of the dog (if said dog returned) and replace with another puppy. We may offer to pay vet costs up to the original purchase price of the dog if the breeder and owner agree. We also reserve the right, at the breeder's expense, to have the dog checked by a vet of our choice before offering a replacement puppy or refunding any costs that have been incurred. We also require all testing been done on said dog be given for evaluation.
6. If the puppy should die from a suspected congenital defect within the 24 months of its date of purchase, an autopsy must be performed at the purchaser's expense by a veterinary teaching hospital or state licenses DVM acceptable to the Seller's own veterinarian. If the autopsy shows a congenital defect as the reason or the death, the Seller will provide another puppy of equal value to the purchaser. A written statement from the veterinarian must be provided. This warranty is void in the event of an indeterminable or inconclusive diagnosis.
7. Seller agrees to provide a pedigree and number of the microchip that has been implanted in the puppy, if applicable.
8. No warranties or guarantees, expressed or implied, are made under its contract except as stated.
9. This warranty is non-transferable.

**Buyer's Responsibility:**

1. The Buyer agrees to pay the Seller a total sum of \$1800. This fee does not include shipping, if shipping is required.
2. The Buyer agrees that their Goldendoodle will be housed indoors.
3. The Buyer agrees to feed their Goldendoodle only a premium quality food.
4. The Buyer agrees to maintain their Goldendoodle at a healthy weight.
5. The Buyer agrees to make and keep annual veterinary appointments for their Goldendoodle and keep all immunizations current according to the guidelines of the AVMA and properly administer heartworm preventative.
6. The Buyer agrees to provide basic obedience training with their Goldendoodle puppy within the first year of owning their dog.
7. The Buyer agrees to postpone strenuous, repetitive exercise until after their Goldendoodle is over one year of age.
8. The Buyer agrees to spay or neuter their puppy before or during the seventh/eighth month of age.
9. The Buyer agrees to contact the Seller immediately if the Buyer determines they are unable to keep their Goldendoodle for any reason. The Buyer and Seller will determine how the dog will be rehomed.
10. The Buyer agrees to never place the Goldendoodle in a shelter, pound or similar facilities or research laboratory.
11. Buyer agrees to pick up puppy at 8 weeks of age or a boarding rate of \$12 per day will be paid to Seller.
